The following Terms and Conditions are dated as of the 27 March 2019. You must pay the cost of shipping the goods to us, but we will pay the shipping cost of replacement goods to you.
  20. For goods that are not faulty or damaged, we can provide a refund within the 7 day money back guarantee period only. All returned goods must be unused, in original packaging and in saleable condition. Receipts must be valid and intact. All return shipping costs from the customer to us are to be covered by the customer.
  21. Where a refund is given for any reason, payments by debit cards through PayPal or Stripe will be refunded back via PayPal or Stripe.
  22. While we make every effort to deliver goods in the time frame we specify, we cannot guarantee delivery on that day or accept liability for deliveries made outside this time frame. We cannot accept liability for out of pocket expenses or other costs incurred by you or by any third party due to failed or delayed deliveries or a lack of availability of the product or service ordered.
